Presbytery Moderator's Message

Royal Commission on Abuse in Care

Additional Notes re the Royal Commission from Matthew Hague

The Inquiry's terms of reference are [at this link](#). This document outlines the purpose of the Inquiry and what they will do with the data. Beyond that, we do not know the details of the Inquiry's work. The point about privacy and the confidentiality of those affected is a relevant one, but privacy is subject to law and in this case the Inquiry has a legal basis to require the information. If there are special reasons beyond the sensitivity of the information that may be relevant, these should be communicated along with the information so the national office can make a decision.

It is critical that information is not held back at the local level, because however well-intentioned that decision may be, there is a high risk that this failure to disclose information may be perceived as an attempt to "cover up" information. This perception alone, as we have seen for other churches, is very damaging and will harm the good work we do based on the trust of the community. Bottom line – there is a legal obligation to disclose the information

The request is for information held by the church. You do not have to investigate and create information. If you hold "historical written data" this should be reviewed to see if there is anything relevant to the request. If any office holders (ministers, members of the parish council, administration or support staff etc) are aware of a relevant issue, even just from memory, this should be disclosed. You do not have to question members of the congregation who are not office holders, what is in their mind is not "held" by the parish

You are only asked to look at information that your parish holds. If you hold information relating to another parish, past or present, it should be disclosed. We cannot disclose information that we do not hold.

Searching your Parish Records—Guidance from Presbyterian Archives in Dunedin

Here is a checklist for searching your parish records.

1. **Talk to members of your congregation** (especially older members). Do they remember any instances of abuse in the parish?
2. **Locate your records.** Your records might be held in your parish, or they could be held at the Presbyterian Archives in Dunedin or at a Regional Repository (a local museum which holds the records of local Presbyterian congregations). A list of regional repositories can be found on our website here; [Regional Repositories for Parish and Presbytery records | Presbyterian Research Centre \(recollect.co.nz\)](#).

If you are in Otago, Southland, or Canterbury your records are very likely to be held at the Presbyterian Archives.

If you are in Wellington your records will be held at the Alexander Turnbull Library.

If you are still unsure where your records are, please contact the Presbyterian Archives. Phone 03 473 0777 or email pcanzarchives@prcknox.org.nz.

3. **Search your records.** You will need to look at the **Session Minutes** and any **Session Correspondence** from 1950 until the present. Concentrate particularly on any period that you have been told that there might have been abuse.

If you know that abuse took place within a parish group such as Bible Class, Choir, Sunday School etc. you will also need to search the records of this group, if they are available.

If the Session Minutes are handwritten and difficult to read, just do your best. It can help to use a magnifying glass to read particularly difficult sections.

4. **What if some of our records are not held in the parish?**

If your records are held at the Presbyterian Archives they will be searched on your behalf. Please tell us if there are periods that we should be concentrating on because there are known instances of abuse.

If your records are held at a Regional Repository you will probably need to arrange for someone to go and look at them at the museum or library where they are held.

5. Fill in the Forms.

Fill in the “**Allegations of Abuse**” form if you find any instances of abuse.

When you have completed your search fill in the “**Description of Search**” form.

Send all forms back to Presbytery by **12th February**.
