Rev Irving Rutherford

Irving Rutherford passed away peacefully at Christchurch Hospital on May 14, 2021, aged 85 years.

He attended the Theological Hall from 1960-62 and was ordained and inducted at Otematata, North Otago Presbytery on 5 March 1964. In May 1965 he married Jean.

Irving was called to Edendale, Mataura Presbytery in April 1967, followed by St Georges, Linwood, Christchurch in December 1977, and then St Stephens, Bryndwr in June 1986. While at St Stephens he undertook a ministry exchange at First Presbyterian Church, Ukiah, California from 1 September 1989 to 30 June 1990.

From July 1996 he was at St James, Spreydon—a shared ministry with Cheviot—and served there until his retirement in December 2000, when he was granted the status of Minister Emeritus.

We give thanks for his life and ministry and pray for Jean and the family.

A memorial Service will be held at St Andrews Presbyterian Church, 16 Merivale Lane, on Saturday, May 29, at 2.00pm.

Notes from Alpine Council Zoom Meetings – March & April

There has been a bit on in Alpine Council including some extra meetings for various reasons.

March

Moderator Barry reflected on a theme from a Brian Zhand book Kiwi Church are using as a Lent devotional exercise, and the figure of Barabbas—a national hero, political insurgent, and freedom fighter—compared to Jesus, a worker for peace and forgiveness hard to understand. There was a recognition that the fighter for freedom enchants us but leads us into a way that does not bring peace.

Key Decisions of Council

From the Human Resources Team:

- Approved the MSB work for St. Martins and advertising a .7 ministry position.
- Clarified that the Rev. Laurence Ennor has had his .5 call to ministry at Oxford Union extended until February 2022, not extended stated supply as our records showed.
- Agreed that the Rev. Martin Harrison's stated supply at Kaikoura be extended for another year or until such time as the application for an exemption to his beneficiary fund requirement is resolved.

- Lyn Heine came onto the HR team as an extra.
- Rev Glenn Livingstone is the Interim Moderator at New Brighton Union

From the Property & Finance Team:

- Endorsed the following grants by the St David's Trust:
 - a. \$40 to the Alpine Presbytery as a contribution to the administration of the Fund.
 - b. \$5,056 to the Hoon Hay Parish for noticeboard, flag, printer, security lighting and cameras under Category C.
 - c. \$1,673 to the Cashmere Parish for a replacement data projector under Category C.
- Approved the application from the Hanmer Project to make further alterations and improvements to the house at 1 Jollies Pass Road, to make it workable as the project hub, based on the list of work provided to a cost of \$86,000 (GST inclusive) allowing for donated labour amounting to \$11,925 and existing Stage 1 funding of \$8,500.
- Approved the application from Crossway Community Church to sell their bare land site at 56-58 Petrie Street Christchurch, for an amount not less than the registered market valuation.

From the Putea Misioni - Alpine Mission Fund

- Agreed that \$20,000 is granted to the Wairau Church Toilet Upgrade, Church Hall on the proviso that the grant will only issue the money if the parish achieves sufficient funds from other sources to embark on the upgrade.
- Agreed that a grant of \$220,000 be approved for the equivalent of a full-time ministry position (plus reimbursements), for an up to two years 'exploration and development of a St Andrew's New Mission Seedling presence' alongside the PSUSI services at the Nga Hau E Wha marae site in Aranui.

Other matters:

- Received the application to resign from the Rev Arii Taimataora from Plains Presbyterian Church. The application to resign lies on the table until the procedures set out in Book of Order have been completed and a decision made. A Commission was established and the Plains Church Council and congregation notified
- The Village Christchurch North Incorporation was approved in principle

April

A Commission was established to visit Knox Waimate because of financial capacity.

Barry reflected on the well-being theme and identifying that he is less assured about all of the package of the church but not the faith. Renovation of the faith journey is important rather than operating on business as usual. He shared some excerpts from Rev Andrew Callander's recent book 'Finding Love' and the methodology of appreciative enquiry which focus on strengths, and invited thoughts and comments from others.

Key Decisions of Council

From the Human Resources Team:

- Mrs Valmai McKenzie (Hakatere) was approved to officiate communion subject to a refresher course with Rev. Johanna Warren.
- Rev. Brent Richardson was thanked for his work as student candidate convenor.
- Rev. Dr. Andrew Nicol and Rev. Dr. Matthew Jack were thanked for their work for a PCANZ workgroup.
- Approved the MSB at St. Andrew's Blenheim's request to proceed with advertising a .5 NOM position.

From the Property & Finance Team:

- Approved the Alpine Financial Statements for the period ended 31st March 2021.
- Acknowledged that the Korean Parish in Christchurch have agreed to the relocation of the cell-phone tower from their previous Purchas Street site to their 75 Packe Street property and associated matters.
- Approved the application from St Paul's Kaikoura to sell a leasehold section for \$350,000 as agreed with the purchaser following a registered valuation.

From the Executive Officer:

- Agreed to the adjustments to the Boundaries & Conflicts of Interest paper as suggested by Rev Rory Grant.
- Agreed to a Memorandum of Understanding be prepared and signed outlining the details of The Village providing oversight of the Prestons and Hanmer Springs New Mission Seedlings.
- Approved a request from Rev Chris Konings for a provisional Certificate Good Standing.
- Approved the addition of Rev Rose Luxford (Oamaru) to the Commission to Waimate.
- Agreed to accept the offer of a subsidy for referrals to Petersgate Counselling Centre and an MOU being signed.
- Recommended Peter Nelson as the Presbytery Representative for the St Andrews College Board.
- Thanked Jean Brouwer, Rev Murray Talbot and Mr Murray Compton for serving on the St Georges Iona Commission.
- Agreed to contract Rev Sage Harris in the role of Youth/Young Adult Resourcing for 5 hours a week, with the

option to review the contracted hours after 6 months.

Heard that Martin Workplace Support are making a donation of \$10,000 as part of their 50th anniversary.

Other matters:

- Rev Rose Luxford and Dr Deborah Bower were forwarded as the Alpine Presbytery nominations for Moderator Designate General Assembly.
- An Emergency Assembly was called to make provision for a back-up Zoom-based Assembly if the Covid -19 status changes. Commissioners were provided from Council .
- Agreed that the following people be Nominated for roles in Alpine Presbytery (subject to final consents) and sent out for voting by Presbytery members:
 - Council: Rev Jason King,
 - Human Resources: Lyn Heine (convener). Rev Anne Stewart
 - Resource Team: Rev Rory Grant (convener), Rev Esther Sabey,
 - Mission Fund: Rev Jonathan Baab,
 - Student Committee: Rev Dr Michael Reid Co-Convener, Mr Malcolm Bishop Co-convener, Andrea Grant

Report of the St Andrew's New Mission Seedling Appointing Group:

• Dugald Wilson (convenor), Phyllis Harris, and Maria Lemalu, with the Executive Officer Martin Stewart in attendance, received five applications and three people were interviewed. The team unanimously recommended Rev Doug McConnell for this role.

Barry acknowledged the contributions of Revs Phyll Harris & Dugald Wilson who are attending their last meeting. Dugald was a founding member of the Council, and Phyll has been HR convener. People acknowledged their appreciation, grief, or relief using emojis. It was an unusual experience!

Another Emergency meeting was held to received the report of the Commission dealing with the resignation of Rev Arii Taimataora from Plains Presbyterian Church. The resignation was agreed to and some follow-up matters approved.
