

Reverend Bob Fendall

We are saddened to advise of the death of Rev Bob Fendall, who died last week.

Bob studied in the Theological Hall from 1961 to 1963. He and Leita were married in December 1961. Bob was ordained in the Clive-Haumoana parish in Hawke's Bay in 1964 and then moved to St George's Linwood in 1970. From there Bob and Leita moved to St David's in Ashburton in 1977 and then back to St Mark's in Upper Riccarton in 1986. He retired from there in July 1998 but continued taking services and worked as the Parish Visitor in the Knox parish for some time.

His funeral will be on Friday 11th August at Knox Church in Christchurch at 1.30pm.

Notes from the 27th July 2023 meeting of Presbytery Council held via Zoom

Present at the meeting were: Rev Phyllis Harris (Moderator), Rev Jonathan Barb, Rev Rory Grant, Lyn Heine, Rev Jason King, Ann McMillan, Rev Lynmaree Sopoaga, and Rev Martin Stewart (Executive Officer).

Devotions: Phyll shared an article from a recent *Refresh* journal written by Lynne Baab (recently from the University of Otago/Te Whare Wānanga o Ōtāko) on nurturing a contemplative stance as one leans into God's presence. Phyll constituted the meeting with prayer.

Conflicts of Interest: None identified

Minutes: The Minutes of the Presbytery Council meeting held on Thursday 22nd June 2023 were endorsed by email, noting that Rev Rory Grant had left that meeting by the time a matter came up re Timaru.

Risk Management: A discussion was held in private on matters of risk.

Moderator's Report: Phyll had been on leave and had nothing to report.

The Executive Officer Report: Martin reported on several aspects of his work.

General

His house is nearer completion: "Anne and I aim to be in by May 2023 (or so!!!)."

He attended the Matariki planning weekend on West Coast along with Hamish Galloway and Katherine Walters. Lyn Heine led this very ably. He preached at Greymouth & Hakatere.

He enjoyed the Presbytery Retreat and valued seeing the higher proportion of elders and women.

He signalled he is having two week's leave in August.

- **Note from Christine Arnold:** Christine wrote expressing her gratitude for the lovely flowers, the gift of a painting and the kind words expressed as she finished in the Treasurer role.
- Pleasant Point: Phyll and Martin have been in a conversation at Pleasant Point people (see below).
- **Report Sawmill Bush, Staveley:** Martin shared a report on the significant environmental preservation/restoration project happening in the Presbytery.
- Presbyterian Support East Christchurch Older Adult/Kaumātua service: A report and request for the next tranche of payment was approved.
- **GA Commissioners:** The list of Commissioners was tabled for approval. 16 commissioners plus 2 young adult commissioners covered by Presbytery. Alpine was eligible for 43 commissioners. The reasons for the low numbers were discussed. The Commissioners list was approved.
- MOU Review The Village & St Andrew's at Rangi Ruru: A request to review the future of the arrangement has come from The Village Church. The arrangement to provide oversight within The Village was signed in October 2019. It was agreed that Martin Stewart and Phyll Harris work with The Village and appropriate others reviewing the future of the MOU.
- Establishing a Pioneering & Management Coordinator position: Following on from the EO Review and in light of other gaps in the Presbytery's staffing levels, a proposed position was outlined. It was agreed,
 - a) That a Pioneering & Management Coordinator position for a 3-year term be established, and
 - b) That Rory Grant work with Martin on finalising the details needed and circulate things to Council. [Note: this is now being advertised as the Presbytery Ministries Coordinator Kaihautū Whakatipu]
- Change to August & September meeting dates: It was noted that the September Council zoom meeting will need to be held at a different time because of the clash with General Assembly.
 The August Council meeting be held on Thursday 31st August via Zoom.
- Mission Fund Review & Recommendations: The changes agreed in principle in April were represented for Council

The initial feedback from the Presbytery membership be considered at the August meeting of Council and inform the next steps.

It was agreed that Rachael Higgs be thanked for her involvement in facilitating the closure of St Lukes, Nelson.

Closure of the Albury-Pleasant Point Parish: Reports of the Commission to close the Albury-Pleasant Point Parish Two reports were received by Council.

It was agreed that

- a. the Albury-Pleasant Point Parish close on 30 June 2023.
- b. that a suitable date be found for the Moderator to formally close the parish.
- c. that an MOU be prepared with Timaru Presbyterian Parish recognising the financial and review arrangements agreed to by the parties.
- d. that the Commission be thanked and discharged.

[Note: Brent Richardson & Rory Grant did not participate in the vote.]

The Property & Finance Report: Ann McMillan reported and Council approved the following recommendations:

- The report being received.
- Supporting an application from Whakatu Presbyterian Parish for an exemption from the 10% MEF deduction from the sale of 271 Songer Street as the funds are to be fully utilised in the building of their new worship centre at Champion Road.
- Acknowledging that on the closure of the Albury Pleasant Point parish:
 - a. The EQ funds of \$103,621.93 be held in Alpine Presbytery as the South Canterbury Development Fund and,
 - b. That Presbytery ask RangzenPro Project Management to scope the feasibility of the use of the property at 102 Main Road, Pleasant Point.
- Approving the updated IM/ MSB Convenor Reimbursement Rate policy as follows:
 - a. People filling these roles to be paid at a rate of \$29.65 per hour.
 - b. Active Ministers to be paid at a rate of \$42.20 per hour.
 - c. The new rates to come into effect from 1 September 2023.
 - d. All parishes with current IM/ MSB Convenors to be separately advised by issue of the updated policy.
- In respect of the application from Oxford Union Church, approving the application to sell their St David's property at 1664 Oxford Street Cust subject to receipt of a market valuation from a registered valuer, Methodist partner support, and CPT support.
- In respect of the application from St Andrew's United Parish Hokitika approving the application to sell their Hari Hari property at 86 Wanganui Flat Road, Hari Hari based on the registered valuation and subject to partner and CPT support.
- In considering the application from Cashmere Presbyterian Parish to subdivide off the Church House and sell it,
 - a. approving the building work required to separate the properties;
 - b. approving the subdivision of the church house from the church and worship centre at 2a Macmillan Avenue, Christchurch,
 - c. approving the sale of the church house land and building, either at no less than market valuation or on the open market, once the subdivision is complete; subject to receiving a market valuation from a registered valuer,
 - d. approving expenditure of up to \$200,000 on the whole project including all aspects of the work required to separate the buildings and the subdivision costs.
 - All subject to CPT approval.
- Confirming the following as the CARG Team for the Alpine Presbytery: Rev Dugald Wilson (Convenor), Rev Stephanie Wells and Gordon Dalkie (architect); and those names bring forwarded to the Nominating Committee for GA23.

Human Resources: Lyn Heine reported and Council received the report agreed

Parish Web-hosting possibility with Webmad

It was agreed that Presbytery approve in principle Webmad being invited to provide parish website hosting through the Alpine Presbytery server, and Rory Grant and Martin Stewart oversee the implementation.


The meeting closed at 12.20pm with a prayer led by Martin Stewart.


