# Notes from Presbytery Council meeting held 29th February 2024 at The Village, Papanui

Present at the meeting were: Rev Phyllis Harris (Moderator), Rev Jonathan Barb, Keith Christie, Rev Rory Grant, Lyn Heine, Rev Jason King (who left the meeting at 2.25pm), Ann McMillan, Rev Brent Richardson, Rev Lynmaree Sopoaga, and Rev Martin Stewart (Executive Officer).

An apology was received from Rev Jon Parkes. Phyll welcomed Keith Christie (Treasurer) at his first in-person meeting.

**Devotions:** Phyll shared an excerpt from Tod Bolsinger's book *Tempered Resistance*, outlining the process involved in a blacksmith tempering metal and the parallels with working as ministry leaders. Resistance to change and the processes to cultivate resilience and holding one's nerve were discussed.

Phyll constituted the meeting with prayer.

**Conflicts of Interest:** Keith identified that he would not participate in matters to do with Whakatu Church.

#### Minutes:

The Minutes of the Presbytery Council meeting held on Thursday 23rd November 2023 had been approved by email and were ratified at the meeting.

The Minutes of the Service of Ordination for Rev Joshua Olds held on Sunday 3rd December 2023 at The Village Church, Papanui, Christchurch were approved.

The minutes of five email decisions of Presbytery Council December 2023 to February 2024 were ratified.

- 1. The formation of the Waihao Glenavy Community Church from 1 February 2024 and appointment of the acting Parish Council. (this follows the closure of the cooperative venture with the Anglicans
- 2. That Alpine Presbytery approve the dissolution of the Waimate Cooperating Parish as at 31 December 2023 subject to the Dissolution Agreement being finalised; meaning the closure of the parish with Presbyterian funds and properties coming to Alpine Presbytery.

That Alpine Presbytery gift the Waihao and Glenavy properties to the Waihao Glenavy Community Church as at 1 February 2024; being 2 Turners Road Waihao Downs and 9 Parker Street Glenavy respectively.

That Alpine Presbytery provide seed funding, from the Waimate Cooperating closure funds, to the Waihao-Glenavy Community Church for the start up at 1 February 2024; amount to be determined.

- 3. Approval of the Terms of Call for Mackenzie Cooperating Church for a full-time minister for a 3-year period at Standard Terms of Call.
- 4. Receiving the resignation of Rev Jon Parkes & establishing a Commission meet with Jon to discuss his resignation using the process in Book of Order 10.23.
- 5. Aranui Iona Project strengthening work approval.

- Wairau: attended worship on 21st January at St. Ninians in Blenheim to induct their Local Shared Ministry team with Rev Reg Weeks as the enabler.
- **Presbytery staff lunch:** It was good to meet with the Presbytery staff over lunch and bring a devotion. As our staff continues to expand this is a good space to connect with all that is going on. It also gives the opportunity to bridge what staff are up to and what council are up to.
- o Sympathy

To Rory and Andrea Grant on the loss of Rory's mum.

- To Rev Alistair McNaughton on loss of his wife Catherine
- To Lesley Hunt on the loss of Rev John Hunt.

# The Executive Officer Report

Martin reported on several aspects of his work, including:

- General: Pioneer Ministries meeting in Hanmer Springs, an Akaroa meeting, Whakatu-related work, helping lead the wonderful Christmas Eve service at Laghmor (near Ashburton) (over 100 people were present!), closure of the Hari Hari Church with the Anglican Bishop & Methodist Superintendent, farewell for Rev Kathryn Walters (the retiring Superintendent), Trinity Temuka LSM team commissioning, Presbytery staff lunch, meetings with various colleagues, time with Russell Garrett (CPT EO) including visits to some new church buildings, and a weekend at Ohope for the PCANZ strategic directions group and work on several papers.
- o Staff: Dan is settling in well.
- o Study Leave: I am preparing for Study Leave in August-September.
- o **Oxford:** They have asked for Presbyterian oversight and process for the next season.

• **St Kentigerns Church:** A process is underway looking a possible way of attending to the future options of the church.

## **Property & Finance**

Key points:

- o The team approved the payment of accounts
- o Updates on projects/ building issues etc
  - a. Iona Project increased cost for Breezes Road work approved by CPT. Building consent has been issued and planned start date 11<sup>th</sup> March for the contractor.
  - b. Rangiora new build has final CPT approval and is underway.
  - c. Amuri sale of the Culverden church: received valuation and approval from the Anglican Diocese. Approved by CPT with conditions.
  - d. St Ninian's site development has been approved.
  - e. Cashmere progress on subdivision and sale.
  - f. Hope Rolleston new build is complete and now officially opened. Costs came in under budget.
  - g. CATAS: the transition of payroll has been completed in February.
  - h. Pleasant Point Property: the feasibility study is progressing well.
  - i. St Luke's Nelson: divestment of property continuing after closure.
  - j. Plains sale of Carew land approved.
  - k. Oxford Union Parish sale of Cust property confirmation due.
  - I. Awatere Christian Joint Venture: approval for application to use PIF capital funds subject to CPT sign off
  - m. Hope Church: approval of strengthening of Hornby building at 27 Amyes Road Christchurch subject to CPT sign off
  - n. approving the 2024/2025 draft budget including the levy rate for 2024-25 at 1.14% of assessable income, being a 5% increase on the previous year, and referring this to the April Presbytery Gathering.

## **Human Resources**

Lyn Heine's report was received, it included:

- o Wairau Parish (Blenheim) have proceeded to establish a Local Ministry Team 21 Jan.
- o Trinity Temuka have proceeded to establish a Local shared Ministry 28 Jan.
- o St Andrews Motueka has Rev Dr Rev Dr Andrew Callander as Stated Supply Minister with the MSB is underway.
- o The Village, Christchurch, have an MSB looking at formalising Rev Josh Olds' position at Papanui. Rev David Sang-Joon Kim (Convenor), Rev Ryan Feng and Kerry Craig are the Presbytery members.
- o Hope require an MSB for the Site Pastor role at Rolleston. Rev Dan Spragg (Convenor), Alison Bishop, and Maria Lemalie will be the Presbytery members.
- o The Complaints and Disputes Manager PCANZ is training more people as Complaints Contact People.
- o Study Leave Report received from Rev Jon Parkes.
- o Amuri (Nth Canterbury) has a ministry review being conducted.

#### General

- o The resignation of Rev Jon Parkes from Presbytery Council was received (from February 2024).
- o The Terms of Call for Rev Sage Harris (Whakatu) are to be amended to the Standard Terms of Call (with no time limit).
- o The resignation of Rev Dr Blair Stirling from the ministry of the PCANZ has been accepted.
- o \$1,000 from the Andrew Norton Scholarship has been granted to Rev Sage Harris for course expenses.
- o Report of the Commission attending to the resignation of Rev Jon Parkes

The Commission, led by Rev Dr Andrew Callander met with Jon & Vivienne Parkes. Being satisfied with the processes leading up to Jon's resignation, the Whakatu Council declined the invitation to meet with the Commission.

The report of the Commission was received and acceptance of the resignation of Rev Jon Parkes (from 30 June 2024) was noted.

- o A paper on things to be considered in how Alpine Presbytery manages operational funding will go to the Alpine Gathering for further engagement.
- o Council will propose to the April Gathering Council that Rev Phyll Harris serve as Moderator for a further year.
- o Discussion was held on matters raised in a written report prepared by Abi Trevathan.

The Alpine Gathering is on 5-6 April at St Margaret's Church, Bishopdale, and the draft agenda was met with approval.

On the Thursday prior to the Gathering we are hosting two events - an Insurance Q&A with Russell Garrett from CPT at 4.30pm, and an Elders Training evening with Andrew Nicol (KCML) after a meal.

- o It was agreed that the Presbytery Youth Fund will support the travel costs for up to three people (two rangatahi and perhaps one youth leader/worker) to attend the noho marae at Ohope in April.
- o It was agreed that Alpine Presbytery be the MOU holder for Forge Aotearoa for a further two years (noting that there were still sufficient funds in the Forge kete).
- It was agreed that an Alpine Gathering with a focus on resourcing ministry leaders be held at Whakatu Church
  1-3 November 2024 (noting that permission to focus the next Gathering in this way will be required from the April Gathering).
- o It was agreed that Hanmer Springs Mission review should be led by two 'outside' people and the wider Presbytery be engaged in the process.
- o It was noted that Megan Waddington was concluding in her position with Presbyterian Support and that she be thanked her for her work.

The next meeting is scheduled for Thursday 28<sup>th</sup> March via Zoom
