horizon and the path to the new dawn will be found.

Phyll reflected on a recent experience at Ohope, hearing the response of the national church to the heartbreaking abuse in care inquiry and being part of a dawn service that read the response of the church and offered it to God. The service included a time of repentance and lament and asking God to lead us forward in healing and in seeking God's justice for those who had been harmed in this way. She was struck by the thought that a part of God's new thing that we wouldn't necessarily expect is correcting the injustices of the past.

A call back to God's heart of justice...and for us to be a people of justice.

A call for us to be unified not divided on the causes of justice that God would call us to speak into including the abuse in care report and our Te Tiriti commitments.

Amos 5:24 tells us "Let justice roll on like a river, righteousness like a never-failing stream."

And Micah 6:8 "He has told you, O man, what is good, and what the Lord really wants from you: He wants you to carry out justice, to love faithfulness, and to live obediently before your God."

Phyll had a sense that we need to:

listen to God and let what breaks God's heart break our hearts;

take notice of the lost and the broken;

take notice of the things around us that are taking hearts and minds captive for evil and not for good;

take notice of the structures and institutions that oppress and marginalize people, and take notice of injustices that are dividing not unifying.

We then need to discern and act where it is in our calling and power to do so allowing God's kingdom to come on earth as it is in heaven.

With Rory's help, Phyll led the following prayer from the PCANZ apology letter:

- He āroha te Atua,
- whakatōhia mai ki roto ō mātau ngākau,
- o mātau hinengaro tou atawhai mē tou ārohanui tonu.
- E whakaarahia ana hoki ē ia te hunga ē whakapiko iho ana.
- He tika ngā ara katoa ō Ihowa: He atawhai hoki ana mahi katoa.
- Ka whakanui ahau ia koe ē Ihowa e Kiingi ō nga Kiingi
- te Ariki o ngā Ariki, kia āwhina i ō mātau hoa tata anō ko mātau.

Loving God of justice and peace refresh our minds and stir our hearts. Show us where we have lost our way. Let us learn from our past mistakes Help us to see a way forward And in doing so May we bring help, peace, and healing to all.

### **Moderator's Report**

Phyll reported

This felt like a significant gathering, coming together for the first time as Presbyteries and the COA on the marae at Ohope to listen for what the Spirit might be speaking to the church. Again, the incredible grace and generosity of Te Aka Puahou in hosting us with such warmth and abundance was gratefully received. The korero was open and informative. The dawn service to lift the church's response to the abuse in car inquiry before God, to offer repentance as a church for those harmed in such a heartbreaking way, and to lift all those harmed before God in healing prayer was a poignant moment.
- liaising with members from the development team for Three Peaks Mission around the final worship service for Plains Presbyterian Parish. This service happened on the Sunday 20th of October. Again, it was a poignant moment in the lives of these people
- attending the Te Raranga Heads of Denominations lunch meeting. Time was spent reflecting on the reasons Te Raranga exists and agreeing on updated principles. Phyll is looking forward to the continued work involving churches and leaders from different ethnicities.
